#### **RESOLUTION NO. 11-03-2016-01**

### A RESOLUTION TO AMEND THE IMPOSITION OF A PER CAPITA TAX UPON RESIDENTS AND INHABITANTS OF BERLIN

WHEREAS, Berlin Borough Ordinance No. 273, adopted July 6, 1989, establishes the imposition of a per capita tax upon residents and inhabitants of Berlin Borough, and

WHEREAS, Section 4 of Berlin Borough Ordinance No. 273 authorizes the adoption of exemptions to the tax by Resolution of the Berlin Borough Council, and

WHEREAS, the Berlin Borough Council desires to provide certain exemptions to the payment of the Borough's per capita tax,

THEREFORE BE IT RESOLVED, and it is hereby resolved by the Berlin Borough Council that residents aged 70 and over will be exempt from the \$5.00 Per Capita Tax, Additionally, residents between the ages of 18 and 69 will be exempt from the \$5.00 Per Capita Tax if the annual income from all sources is less than \$5,000 for individuals and \$10,000 for couples with income from all sources to include Social Security payments, Welfare payments, interest, dividends, lottery and gambling winnings, support provided by others, and all income from whatever source derived. Additionally, students, members of the clergy, and members of the military armed forces will be exempt from the \$5.00 Per Capita Tax.

BE IT BE FUTHER RESOLVED, that this Resolution becomes effective with the 2017 calendar year.

### **Committee Reports:**

#### **Electric: Chair Eric Glotfelty**

1) Generator Project update – PowerSecure has employees onsite this week to complete the generator assembly. We are waiting on an additional DEF tank to arrive to fuel the system in preparation for the start up.

The following are tentative delivery dates:

- Recloser ship on 11/4. These will ship to Weidenthoft's and are to be installed by them.
- Pole mount PT/ CT's these will also ship to Weidnehoft's shop and should ship on 11/13.
- Transformers these will go directly to the site and are expected to arrive in late November.

All of these items are to be mounted and terminated no later than 11/25. PowerSecure plans to have a start-up crew onsite 11/28 to begin running everything. It is expected to take a couple of weeks of onsite testing before the generators are commissioned by mid-December.

Once again someone is trying to derail or undermine the Generator Project. Premature complaints were made with the PA DEP about the registration and certification of the diesel fuel tanks. The tanks have been tested and certified by PowerSecure during the manufacturing process. A PA DEP certified tank inspector is reviewing the design of the tanks and will be making a site inspection visit by the end of next week.

Council Member Barb Zerfoss asked what is wrong with the fuel tanks. Secretary Jones replied that nothing is wrong with the tanks. The manufacturer's blueprints and specifications were forwarded to the inspector. PowerSecure has designed the generator and tanks to meet or exceed all regulatory agency guidelines throughout the United States. Once the inspection has been done, the DEP will issue permit stickers allowing the fueling of the tanks. The frivolous complaints are similar to those made about building permits and soil erosion compliance that only caused the Borough to incur unnecessary time and expenses.

1) We have solicited prices for a chain link security fence to be installed around the generators. Custom Fencing of Ligonier and Laurel Highlands Fence Company of New Stanton were the only companies that submitted proposals.

2) Berlin Oil Company has offered the lowest price for the purchase of 5,000 gallons of diesel fuel for the generators. It is anticipated the fuel will be needed in mid-November after the transformers are delivered and installed.

Council President Custer asked if we should advertise for bids for the fuel purchase. Secretary Jones stated that currently the Borough Code requires advertised bids only when the amount exceeds \$19,400.00. The amount is below this threshold and also the \$10,500.00 requirement for 3 written quotes. However, 4 quotes were obtained from area vendors – Berlin Oil Company, Somerset Fuels, Shaffer Oil, and Luther P. Miller. Berlin Oil Company had the lowest priced quote.

3) Fiber is required for communication for monitoring and activation of the generators. Approximately 4,000 feet is needed to run the fiber from the Vine Street to the Borough Office. PowerSecure has offered to provide this at a cost of \$3,000.00. Weidenhoft can install the fiber for the Borough.

AMP SOLAR REPORT – Secretary Jones reviewed a power point presentation on the AMP Solar Project II participation. AMP is purchasing up to at least 80 megawatts or more of solar produced electricity from NextEra owned facilities. This will be behind the meter generation. Savings will be realized from SREC's, transmission savings, and capacity savings. To participate, AMP is requiring a 25 year contract commitment for approximately 3% of the Borough's projected power requirements at a fixed level cost of \$33.00/megawatt (\$0.033 per kWh). We are currently paying \$0.065-\$0.07/kWh.

Council Member Roger Clarke said this is a no brainer since we have not seen prices that low in a long time. President Custer stated that this was a nice addition to our current power purchase portfolio.

#### **RESOLUTION NO. 11-03-2016-02**

# A RESOLUTION TO APPROVE THE FORM AND AUTHORIZE THE EXECUTION OF A POWER SALES CONTRACT WITH AMERICAN MUNICIPAL POWER, INC. AND TAKING OTHER ACTIONS IN CONNECTION THEREWITH REGARDING PARTICIPATION IN THE AMP SOLAR PROJECT II

WHEREAS, the Borogh of Berlin, Pennsylvania (the "Municipality") is a political subdivision organized and existing pursuant to the laws of the Commonwealth of Pennsylvania which owns and operates an electric utility system for the sale of electric capacity and associated energy for the benefit of its citizens and customers;

WHEREAS, in order to satisfy the electric capacity and associated energy requirements of its electric utility system, the Municipality has heretofore purchased, or desires to do so in the future, economical and reliable electric capacity and associated energy from, or arranged by, American Municipal Power, Inc. (hereinafter, "AMP"), an Ohio non-profit corporation, of which the Municipality is a AMP Member;

WHEREAS, the Municipality, acting individually and, along with other municipalities which own and operate electric utility systems, jointly through AMP, endeavors to arrange for the availability of reliable, environmentally responsible, reasonably priced supplies of electric capacity and associated energy for ultimate delivery to or on behalf of its customers;

WHEREAS, it is efficient and economical to act jointly in such regard;

WHEREAS, AMP is an Ohio nonprofit corporation, organized to own and operate facilities, or to provide otherwise for the generation, transmission or distribution of electric power and energy, or any combination thereof, and to furnish technical services on a cooperative, nonprofit basis, for the mutual benefit of its Members, such Members, including the Municipality, being, and to be, political subdivisions of their respective states that operate electric systems in, as of the date of adoption hereof, Delaware, Indiana, Kentucky, Maryland, Michigan, Ohio, Pennsylvania, Virginia, and West Virginia;

WHEREAS, Municipality has determined it requires additional long-term sources of reliable, environmentally sound and reasonably priced electric capacity and energy and has requested that AMP arrange for the same;

WHEREAS, in furtherance of such purpose, Municipality, along with other Members (collectively, "Participants") requested and AMP agreed that it will either directly by itself or otherwise arrange for the financing, acquisition, construction, operation and ownership, in whole or in part, of solar generation at agreed upon solar sites and possible additional solar sites having an expected net rated electric generating capacity of up to an aggregate total of a nominal 80 MW (or such larger amount as approved or set forth in the AMP Solar Project II Power Sales Contract (hereafter "PSC")) capacity (to be known collectively as the "AMP Solar Project II");

WHEREAS, AMP has resolved, in accordance with the PSC, to develop, including, as appropriate, the financing, acquisition, construction, ownership and operation of, and arrangements for the acquisition, financing, and payment for the AMP Solar Project II as well as other arrangements related thereto, which AMP and, in certain cases, the Participants, deem necessary to enable AMP to fulfill its obligations hereunder to sell and transmit, or otherwise make available, electric capacity and energy to the Participants;

WHEREAS, the PSC between AMP and Municipality, a copy of the form of which is on file with the Clerk, sets forth the terms and conditions, rights, duties, obligations, and covenants of the parties with respect to the AMP Solar Project II;

WHEREAS, in order to lower the Project costs to the Municipality and other Participants, AMP is investigating utilizing a "tax equity investor" structure for Solar Project II as contemplated in the PSC;

WHEREAS, AMP has provided appropriate information regarding the AMP Solar Project II, as such officers and representatives of the Municipality deem necessary or appropriate, to enable the Municipality to evaluate the benefits and risks of the AMP Solar Project II, to take actions contemplated by the Resolution hereinafter set forth and to determine that the same are in the public interest;

WHEREAS, the proposed form of the PSC has been reviewed by this body and this body has been advised on the same;

WHEREAS, in order to obtain such sources of electric capacity and energy, the Participants are willing to pay AMP for their respective rights to such electric capacity and energy and transmission service at rates that are sufficient, but only sufficient, to enable AMP to (i) recover all costs and expenses incurred with respect to, and arrangements for the acquisition, financing, and payment for the Project as set forth herein, and related service arrangements undertaken by AMP to enable it to fulfill its obligations hereunder, and (ii) recover any other expenditures or revenues authorized hereunder as more fully set forth in the PSC;

WHEREAS, AMP and certain Members have determined that the AMP Solar Project II is an appropriate and reasonable option for AMP Members and it is necessary and desirable for this body to approve AMP Solar Project II and the form of the PSC; and

### NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE BOROUGH OF BERLIN, PENNSYLVANIA.

SECTION 1. That the PSC, substantially in the form on file with the Clerk, including Appendices thereto is approved, and the Executive Borough Secretary or the Executive Borough Secretary's designee is hereby authorized to execute and deliver such PSC, with such changes or modifications as the Executive Borough Secretary or the Executive Borough Secretary's designee may approve as neither inconsistent with this Resolution nor materially detrimental to the Municipality, his execution of the PSC to be conclusive evidence of such approval, including without limitation, PSC modifications designed to accommodate a tax equity investor should the Participants and AMP find it advantageous to the Participants to structure the AMP Solar Project II or its ownership with a tax equity investor,.

SECTION 2. That the Executive Borough Secretary is hereby authorized to acquire on behalf of the Municipality, as a Participant, as defined in the PSC, a Project Share as defined in the PSC, without bid, from AMP of up to 400 kW and to execute and deliver any and all documents necessary to become a Participant in the AMP Solar Project II pursuant to the conditions set forth herein and in the PSC and to carry out its obligations thereunder as the Executive Borough Secretary deems in the best interests of the Municipality:

SECTION 3. That the Executive Borough Secretary of this Municipality, as a part of such officer's official duties, is hereby appointed as Municipality's representative for any meetings or determinations of the Participants or the Participants Committee pursuant to the PSC and is authorized and directed, acting for, in the name of and on behalf of this Municipality, to vote Municipality's Project Share with regard to any determinations regarding the AMP Solar Project II as set forth in the PSC.

SECTION 4. That the Executive Borough Secretary may appoint, in writing from time to time as necessary, another representative of the Municipality as his or her alternate to carry out the duties set forth in Section 3 hereof.

SECTION 5. That is it found and determined that all formal actions of this body concerning and relating to the adoption of this Resolution were adopted in an open meeting of a quorum of this body, and that all deliberations of this body and of any its committees that resulted in such formal action, were held in meetings open to the public, in compliance with all legal requirements.

SECTION 6. If any section, subsection, paragraph, clause or provision or any part thereof of this Resolution shall be finally adjudicated by a court of competent jurisdiction to be invalid, the remainder of this Resolution shall be unaffected by such adjudication and all the remaining provisions of this Resolution shall remain in full force and effect as though such section, subsection, paragraph, clause or provision or any part thereof so adjudicated to be invalid had not, to the extent of such invalidity, been included herein.

Motion by Brett Custer and seconded by Eric Glotfelty adopting Resolution No. 11-13-2016 to approve and authorize the execution of a power sale contract with American Municipal Power, Inc. and taking other actions in connection therewith regarding participation in the AMP Solar Project II.

4) On Wednesday, October 26, the 1,000 KVA transformer failed at Meadowview Nursing Home. Wiedenhoft Electric replaced it with a 750 KVA transformer that was in our inventory. Brian is recommending that we purchase a 1,000 KVA transformer for inventory stock. The price of a rebuilt 1,000 KVA transformer from T&R Electric is \$18,100.00 with a

4-6 week lead time.

#### **REFUSE: Chair Roger Clarke**

There are still some people "dumpster diving" in the dumpsters at the maintenance shed and the Borough should do something about it such as posting signs, assessing fines on those caught doing it, etc. There are concerns about liability to the Borough if someone gets injured getting into or out of the dumpsters, and about citizen's privacy if bags are torn open and mail, bills, and other items are obtained with sensitive information on them.

Council directed Secretary Jones to check with other Boroughs to see what they are doing about similar situations. He will also check with the PSAB for guidance.

#### **EQUIPMENT: John Harding**

- 1) New refuse truck the garbage truck was delivered on Thursday, November 3, 2016. The refuse employees received orientation on the operation of the vehicle today. After a waste hauler sticker is obtained from the landfill, the vehicle will be placed in service.
  - There was discussion on what to do with one of the two older trucks. It was suggested that one be sold. Action was tabled on this matter until the next Council meeting.
- 2) The 1960 Caterpillar Front End Loader the parts needed to finish the repairs are being put on and the loader should be returned to us next week by Jim Snyder.

#### STREETS & SIDEWALKS: Chair Eric Glotfelty

- 1) The 6 inch water line and the sewer line have been placed from Orchard Street south to the end of Vine Street. The pavement was removed down the center of Vine Street approximately 2 feet in width. This has been backfilled with dirt. Chad Lowery recommends that a stone base be put in and then covered with asphalt cold patch until such time the street is paved over.
  - Council directed the Secretary to have the public works place a stone base and cold patch over the area dug up.
- 2) The Solicitor recommends that there be a survey made of Birch Alley in order to vacate the street per Title 8, Pennsylvania Consolidated Statutes, Subchapter D. Section 1731 and Section 1732. He will draft an ordinance to vacate the street and we need to publish it in the newspaper and send notice to all abutting property owners. He suggested the property owners obtain legal advice on the division and ownership of the street after it is vacated by the Borough. A public meeting will be held immediately prior to the next council meeting at 6:45 p.m. on December 1, 2016.

Barb Zerfoss asked Brett Custer how and when he is going to replace the sidewalk at the log house on West Main Street. She stated she had received several questions and complaints about the sidewalk. Mr. Custer replied that he has been held up waiting for at least 6 months to get direction from Council on the color and stamping design to be used. Only recently, Council members Roger Clarke and Tom Fisher met with Sanner Concrete and decided on a color and stamping design. Mr. Custer emphasized that Custer Holdings will be paying 100% of the costs for the walk and that the Borough will not be paying for anything.

#### **POLICE: Chair John Harding**

A new computer is need for the police department. It is used for storage of the photos and footage for the police cruisers, as well as for other police uses.


- Power Purchase Agreement between AMP and NextEra's wholly owned subsidiary (DG AMP Solar LLC) for up to 80 MW or more of solar facilities behind members' meters
- NextEra will build, own and operate all solar sites
- AMP will purchase 100% of the output from the solar generation
- AMP will prepay NextEra for a portion of the output
  - AMP will have security lien on the project



# Solar Phase II Rate Projections

- Based on Initial Estimates and Interconnection Costs for all twenty-six Tier I and II sites
- AMP will prepay for a portion of the energy after COD of each site
- AMP will pay NextEra Take and Pay charge of fixed (no escalation) \$10.38 / MWh
  - Charge for "Capacity and Attributes"
- Project/Participants keep 50% of SRECs and 100% of Transmission and Capacity credits



# Financing Plan

- Tax Exempt Financing 25 year term
  - Assumed 4.0% interest rate
  - Effective levelized (flat) rate of approximately \$86.81 / MWh, before any credits
    - Assumed 0.75% degradation rate
  - \$85.00 / MWh with 0.50% degradation rate
- Taxable Financing 30 year term
  - Assumed 5.3% interest rate
  - Effective levelized (flat) rate of approximately \$88.94 / MWh, before any credits
    - Assumed 0.75% degradation rate

# Energy

Kilowatthours consumed by customers and produced by generators

# Capacity

 Ensuring that there is enough generation available to supply customers during period of maximum usage

### Transmission

Electric lines connecting generators to municipal system

### Behind the Meter Generation

- Solar typically generates during the transmission and capacity peak billing hours
  - This lowers the meter between PJM and the Municipality
- The savings from the lowered meter is then passed back to the Participants of the project
  - Project Participants receive share of peak shaving savings from all sites






# Solar Output Curve

### Solar Output is typically at 55% of Maximum at time of Peaks


Peaks are normally at 5:00 pm EDT in Summer

Figure 8-10 Average hourly real-time generation of solar units in PJM: January through September 2015







- Tier I Site Construction August 2016 1<sup>st</sup> quarter, 2017

- Total Project Solar Phase II Subscription Deadline is COD of Bowling Green site: November 1, 2016
- Tier II Site Construction January December, 2017

### Solar Phase II Recommendation

- Solar Phase II provides:
  - Diversity of locations
  - Hedge against rising capacity and transmission costs
  - Slight reduction to overall power rate
    - Solar subscription recommended by Leidos would make up ≈2% of total power costs



# Solar Phase II Project Summary

- Multiple sites diversifies risks and increases benefits of peaking savings and SRECS
  - Allows for solar participation without having a site
- Solar provides peaking <u>capacity</u> and <u>transmission</u> savings and SRECs
- Provides <u>energy</u> during the highest priced hours of the day
