Tom Glessner presented a chronological list of the occurrences associated with the project 210197. The delays and issues that were encountered through Columbia Gas, PennDOT, the borough and how it affected construction. Kevin confirmed the timing and supported the issues that have been encountered. Kevin explained the increase in material costs from 2020 to 2021 as well as the surface of the sidewalks. The borough solicitor's review - according to Section 1002 of the Borough Code, states that the Council members must take and subscribe to the oath before undertaking the duties of their office and that the mayor can give the oath. It says nothing about the mayor having to take the oath before swearing in the council members. Therefore, without any further guidance under the law, it will be fine; however, for future reference the mayor needs to take the oath and sign it before undertaking mayoral duties.

Appointment of Auditors: Tom Glessner has confirmed Terry Dephillips would accept and is working on additional auditor. If it's OK, Council can make the appointment next meeting.
