Since the salary of the Council President is more than \$500.00 above the salary of the rest of other Council members, the PSAB recommends that a nominee not vote for himself in order to avoid any potential conflict of interest or violation of the Pennsylvania Public Official and Employee Ethics Act. The first nominee who receives a majority vote will then become the presiding Council President until the next reorganization meeting of the Borough of Berlin Council. I will then pass the gavel to the President and he or she will preside over the remainder this reorganization meeting.”
